#### **REPORTING**

BGS encourages personnel to report hazards to ground operations using various safety reporting procedures such as Sensus system reporting, Near Miss system. We recognize that hazard reporting is vital for identifying and addressing potential risks, ensuring the safety of our operations. We provide clear guidance and support to employees on how to report hazards and ensure that all reports are treated seriously and investigated promptly and if needed confidentially.



#### **OPERATIONAL BEHAVIORS**

Certain types of operational behaviors, such as illegal activity, substance abuse, gross negligence, or deliberate disregard of regulations, are deemed unacceptable at BGS. Disciplinary action will not be taken when employees report safety concerns through the designated reporting procedures, except in cases of the aforementioned unacceptable behaviors. All personnel are responsible for adhering to applicable laws, regulations, and procedures at every location where operations occur. By ensuring compliance, we maintain safety, security, and operational efficiency, while emphasizing the importance of awareness, training,
